St. Joseph County 4-H Horse/Pony Project Rules

Developed and approved by the St. Joseph County 4-H Horse Council

General 4-H Horse/Pony Project Rules

- 1. **4-H Member Project Enrollment Forms** (for any and all projects) are due in the St. Joseph County MSU Extension office by December 1 of the new project year.
- 2. Exhibitors in the horse and pony project area may own, borrow, lease or share their project animal(s). *Note: See Horse Sharing rules.
- 3. All 4-H Horse/Pony project animals must be registered in the St. Joseph County MSU Extension office by May 1 of the current project year. Registration information must be submitted on the 4-H Horse/Pony Project Animal Registration Form (available from your horse club organizational leader). Members are responsible for supplying the following information regarding each project animal: name, breed, sex, age, color/distinguishing markings, plus breed registration number and/or 4-H pony county registration number where applicable. A 2" x 3" identifiable, CLEAR FULL BODY SIDE VIEW COLOR PHOTO must be attached to 4-H Horse/Pony Project Animal Registration Form.
- 4. Refer to 4-H Bulletin, *Michigan 4-H Horse, Pony & Miniature Project Show Rules and Regulations*, for 4-H horse show rules and regulations set forth by the State 4-H Horse Project Developmental Committee, including rules and regulations and information on appropriate tack and dress for a given class. **Note:** In general, the Michigan 4-H Horse/Pony/Miniature Project rules will be followed in any and all 4-H Horse Council-sponsored shows and in 4-H horse/pony/miniature classes at fair. However, the 4-H Horse Council has the authority to develop and approve, if deemed appropriate, 4-H Horse/Pony/Miniature Project rules <u>specific</u> to the St. Joseph County 4-H Horse Program which take precedence over state 4-H rules contained in this bulletin.
- 5. 4-H officials expect courteous and orderly conduct by exhibitors and attendees at 4-H Horse Project events/shows. Harassment, profanity or unsportsmanlike conduct toward show officials, judges, staff, leaders or other exhibitors will **NOT** be tolerated.

Pony & Miniature Measurement Dates/Rules/Procedure

- All 4-H project animals intended for show in **pony and miniature classes** at any 4-H Horse Council-sponsored show (for which pony or miniature classes are offered) and/or at the St. Joseph County Grange Fair *must* be measured during the current project year in order to establish "show height". NOTE: If the project animal in question is five (5) years old or order, <u>and</u> an official St. Joseph County 4-H "show height" has been established for the animal previously, re-measurement is not necessary.
- 2. Attention! The 4-H Pony Measurement Check-In Form must be completed and turned in to the pony measurement <u>steward</u> at the time of measurement. An official breed measurement card will be accepted from current year or to establish permanent show height of an animal 5 years and older.. A copy must be turned in with May 1 sign ups.

St. Joseph County Rules Governing 4-H Project Animal Changes

- 1. All 4-H horse/pony project animals must be registered with the St. Joseph County MSU Extension office by May 1 of the current project year on the official 4-H Equine Project Animal Registration Form.
- 2. Eligibility for Requesting a Project Animal Change: A given 4-H member may <u>only</u> make a formal project animal change request if he/she has <u>no</u> (zero) other project animal(s) registered in his/her name for the specific discipline.
- 3. Procedure for Formal Change Request: The procedure for making a project animal change request, for those 4-H members who <u>meet</u> the <u>eligibility requirement</u> for requesting a project animal change (as noted directly above), is as follows: Obtain a copy of the 4-H Equine Change Request Form from the St. Joseph County MSU Extension 4-H website. The form requires submission of the following information:
 - Name, breed, registration number (if applicable), gender, age, color, distinguishing markings, and a color side view 2" x 3" photo of the horse/pony the member is requesting to be <u>added</u> to his/her official project animal registration form.
 - Name (and registration number if applicable) of the project animal to be <u>deleted</u> from the member's official project animal registration form.
 - Reason(s) why the project animal change is being requested.
 - Required <u>written leader comment</u> regarding his/her support or non-support for the project animal change being requested. Leader comment portion of the Project Animal Change Request Form *must* be <u>completed</u>, <u>signed</u> and <u>dated</u> by the member's own 4-H horse club leader. Note: The club leader is encouraged to supply any additional information, above and beyond that supplied by the 4-H member, that will help the 4-H Horse Council Project Animal Change Review Board better understand the reason(s) for the change request.
 - Veterinary Slips: A veterinary slip <u>must</u> be submitted in <u>addition</u> to the 4-H Horse/Pony Project Animal Change Request Form if the reason for the change is <u>medical</u> in nature (including due to an injury to the animal). The veterinary slip must be on the veterinary clinic's official letterhead, and must be <u>completed</u>, signed and dated by the attending veterinarian.
- 4. Submission of Completed Change Request Form: Completed 4-H Project Animal Change Request Form (with veterinary slip attached where applicable) must be submitted to the St. Joseph County MSU Extension office, Centreville, Michigan at least <u>one (1)</u> working day prior to the next regularly scheduled 4-H Horse Council Meeting. The 4-H office will then notify the 4-H Horse Council President regarding the receipt of the change request form. (Call 269/467-5521 for assistance, if needed, in obtaining the <u>date</u> of the next regularly scheduled 4-H Horse Council Meeting.)

- 5. Last Date for Submitting a Project Animal Change Request Form: The last possible date for submitting a 4-H Horse/Pony Project Animal Change Request Form to the St. Joseph County MSU Extension office is September 1 of the current project year. Office hours are 8:00 a.m. 5:00 p.m. Monday through Friday. Any and all project animal change request forms received <u>after</u> September 1 will <u>NOT</u> be considered by the Project Animal Change Review Committee.
- 6. **Change Request Review Process:** The 4-H Horse Council <u>president</u> will be notified that a project animal change request has been received. The president will notify the other members of the Project Animal Change Review Board of the need for a meeting to be held <u>prior</u> to the next regularly scheduled 4-H Horse Council Meeting.

The review board has been authorized to make the decision whether or not to approve a given change request. A minimum of 75% of the board members must be present at the meeting in order for a given change request to be approved/disapproved. **Note:** The <u>president</u> of the review board will inform the 4-H Horse Council of the outcome of the project animal change request at the council's next regularly scheduled meeting.

7. **Member Notification of Change Request Outcome:** The 4-H member who made the change request will be notified of his/her 4-H Horse/Pony Project Animal Change Request Form with the board's decision to approve/disapprove the change request noted on the form.

St. Joseph County 4-H Horse/Pony/Miniature Project Fair Rules

- 1. All project members, leaders and parents are responsible for reading and following all rules contained in the 4-H/FFA & Other Youth Fair Premium Book which pertain to the 4-H Equine Project, including:
 - St. Joseph County 4-H Participation/Conduct Policy
 - General Rules
 - General Animal Science Rules
 - Michigan Department of Agriculture Rules and Regulations for Exhibiting Livestock in Michigan
 - 4-H Horse/Pony Project Rules found under Department 16
- Required Leader Observation: Each 4-H member wishing to exhibit a horse/pony in 4-H classes at the St. Joseph County Grange Fair <u>must be observed</u> working with the project animal(s) in question by his/her <u>4-H Horse Equine project leader</u> during the current project year in order to be <u>eligible</u> to participate in <u>4-H horse/pony/miniature classes</u> at the fair. Attention: Leader observation <u>must</u> be completed by September 1!
- 3. All 4-H horse exhibitors must stable a 4-H project horse/pony/miniature in the 4-H barns at the fairgrounds until 5:30 a.m. on Sunday following fair unless 4-H exhibitor meets the exceptions of the 4-H Program Coordinator and/or veterinarian (exceptions determined yearly). (Refer to 4-H fair rule book.) Exhibitors who remove their project animal(s) from the fairgrounds prior to this date and time without approval will <u>forfeit</u> their 4-H horse project-related <u>premiums</u>. Note: This is a St. Joseph County Grange Fair rule. Exhibitors are required to leave their exhibits on display in exchange for fair premiums.
- 4. Required "Thank You" Notes for Trophies/Special Awards: Each 4-H member who wins one or more trophies/special awards in <u>4-H horse/pony/miniature classes</u> at the St. Joseph County Grange Fair is <u>required</u> to write a "thank you" note to the trophy donor(s). The completed, properly addressed, stamped "thank you" note for a given trophy must then be submitted during *4-H Trophy/Special Award Pick-Up* on the <u>final Saturday</u> of fair in 4-H still project exhibit building No. 43. The pick-up period will run from 10:00 11:00 p.m. Volunteers will be on hand to assist with accepting the "thank you" note in exchange for a given trophy/award. Note: Donor names/addresses will be posted in Building No. 43 during fair week.

Required Leader Review of "Thank You" Notes: All "thank you" notes *must* be reviewed by the member's 4-H club leader. The leader must <u>initial</u> and <u>date</u> the backside of the envelope if he/she <u>approves</u> of the content of the member's "thank you" note. If the leader does <u>not</u> approve of the content of the note, he/she needs to work with the member (and the member's parents if necessary) on making improvements to the note. A given trophy/special award will <u>only</u> be distributed in exchange for a <u>properly</u> initialed and dated note.

5. At fair, horse/member combination can only enter one (1) type of showmanship and one (1) type of horsemanship class in Horse/Pony/Mini.

Western/English Riding Pattern




Figure 21. English/western Riding Pattern

Figure 21 illustrates the English/western riding course. The American Quarter Horse Association (AQHA) western riding pattern 2 is also acceptable; however, if it is to be used, copies of the pattern should be provided to judges and exhibitors well in advance of the class. The use of the gate is recommended but optional, and at the discretion of the local show committee and according to local conditions. The short, double line on the pattern represents a swinging gate that the horse, on entering the arena, must but the rider in a position to open, pass through and close without dismounting. The gate may be located in any convenient part of the arena where it will not interfere with the balance of the routine. Care should be exercised in selecting a gate that will not endanger the horse or rider.

The eight small dots represent markers (barrels, kegs or cones are recommended). These should be separated by a uniform distance of not less than 30 feet and no more than 50 feet. The distances may be altered if the local arena is too small.

- 1. The horse will be judged on quality of gaits, changes of lead, response to the rider, manners, disposition and intelligence.
- 2. The horse should maintain an even cadence and change leads precisely and easily, front and rear, at the center point between markers as indicated by the shaded areas on the pattern. The horse should have a relaxed head carriage showing its response to the rider's hands, with moderate flexion at the poll. The tail should remain quiet throughout the pattern. The horse should cross the log at the jog or pleasure gait and lope without breaking gait or radically changing stride.
- 3. Additional information about the pattern follows.
 - The arrows on the lines indicate the direction of travel and the type of line indicates the gait.
 - The log should be at least 8 feet long and laid on the ground.
 - The markers should be pylons. In the row of five markers, the markers are separated by equal distances of 30 to 50 feet. The markers in the row of three are aligned with the first, third and fifth markers in the row of five.
 - After stopping and backing at least 10 feet at the end of the pattern, the rider will report to the judge to be excused.
- 4. A horse going off pattern is disqualified. Off pattern is any of the following: an incomplete pattern, incorrect order of maneuvers, knocking over markers, passing on the wrong side of markers, making extra loops in the pattern, missing the log, five or more simple lead changes, and failure to change leads.

- 5. The judge may require an exhibitor to repeat or reverse any part of the routine.
- 6. Only one hand is allowed on the reins and only the index finger is allowed between the reins. Except when negotiating the gate, the hand on the rein cannot be changed. When romal reins are used they will be carried as described under "Stock Seat Equitation" in the Western Division.
- 7. The running walk or other pleasure gait is acceptable for any horses that do not jog.
- 8. Each rider will enter the ring with a score of 70, which represents an average performance. Final scores will generally fall in a range from 40 to 80 points.

0 = average

- Scoring guidelines: Points will be added or subtracted from the eight maneuvers on the following basis.
 - -1 = very poor $+ \frac{1}{2} = good$ $-\frac{1}{2} = poor$ +1 = excellent

- The eight maneuvers are:
 - a. Gate (recommended but optional)
 - b. Trot over the log
 - c. Trot and transition to lope
 - d. Line (side) lead changes (plus or minus 1 point per change)
 - e. First two crossing lead changes (plus or minus 1 point per change)
 - f. Lope over the log
 - g. Second two crossing lead changes (plus or minus 1 point per change)
 - h. Lope, stop and back a minimum of 10 feet
- An additional score of plus or minus 1 point will be given for pat- tern accuracy and smoothness.
- Contestants will be penalized as follows:

5 points

- Releasing the gate due to the horse's disobedience, knocking over or being unable to complete gate
- Failure to change leads where indicated in pattern
- 3 to 5 points
- Using the free hand to instill fear in the horse
- 3 points
- Breaking gait at a lope, including a simple lead change
- Making extra lead changes anywhere on the course
- Breaking gait at a walk or jog for two or more strides
- Failure to begin lope within 30 feet after crossing log

2 points

- Failing to take a prescribed gait at the designated point in the pattern
- Failing to change lead behind until the next change point

1 point

- Breaking gait at a walk or trot up to two strides
- Hitting the log
- ½ point
- Touching the log lightly
- Failing to change lead behind from one-half stride up to a cone

Disgualifications – Failure to perform at least four flying lead changes will result in disgualification.

- The following are considered faults and should be penalized at the judge's discretion:
 - Opening mouth excessively or throwing head on maneuvers
 - Anticipating signals or early lead changes
 - Stumbling
 - Losing a stirrup or holding on
 - Any unnecessary aid given by the rider, such as talking, pet- ting, spurring, quirting or jerking the reins.

Gymkhana Funnel Barrels

Funnel Barrels is a pattern that is widely used in training. It allows you to enter one gate and exit another to keep the class moving along. It allows the judge to look at horsemanship as it pertains to barrels. A judge should be able to control the speed of the class by asking the exhibitor to go at a gait the judge is comfortable with. After completion of the pattern work all exhibitors will return to the center of the ring. Judge may ask for a back, examine tack or do any further individual work-off's if needed. Class will be placed from there.

Required Contest Gear

- 1. Helmet
- 2. Breast Collar
- 3. Single rein or split reins tied

The Rider


- 1. Encourage pull reining, reins in your right hand turning right, reins in your left hand turning left. Both hands on the reins acceptable but should be leaving the barrel with outside hand on the horn.
- 2. Outside hand on the saddle horn for balance.
- 3. When turning a barrel, rein hand should be pulling somewhere between the knee and hip. The horse's nose should be bent to the barrel.
- 4. Use the inside rein to move your horse laterally, and to move its shoulder away from the barrel.
- 5. Check your horse going into a turn. This may be a slight tug on the reins to get his butt underneath him, or it may be done vocally. At this time the rider's weight will drop in the saddle and legs will become still.
- 6. As the horse comes to the back of a barrel the rider should be looking to the next barrel.
- 7. Push the horse off the barrel (leaving the barrel) with your legs and voice. Free his head when you've got your line to the next barrel.

The Horse

- 1. The horse's nose should be tipped to the barrel, and its entire body should be bending.
- 2. The horse should be able to move laterally.
- 3. The horse should be turning in the pocket.
- 4. The horse should respond to the check by gathering himself.
- 5. The horse should set pivot foot.
- 6. The horse should be on the correct lead when turning the barrel.

Faults

- 1. Neck Reining
- 2. Rider's legs too far behind them.
- 3. Kicking into the turn.
- 4. Not checking your horse.
- 5. Running off at the barrel
- 6. Balking at the barrel
- 7. Shouldering the barrel.
- 8. Knocking over a barrel.
- 9. Wrong lead turning a barrel
- 10. Balancing on the horse's mouth instead of the saddle horn.
- 11. Grabbing the back of the saddle.
- 12. Turning the barrel in the wrong direction.



Explanation of Miniature In-Hand Classes

In-Hand Trail/Obstacles (46" and under): This class is to be judged on performance and way of going with emphasis on manners throughout the course. Responsiveness and willingness of project animal is to be considered.

- Pony to be shown in halter with appropriate lead, chain on lead is permitted.
- Pony to be penalized for any unnecessary delay or excessive time at an object. Judge can advance an exhibitor to the next obstacle if a pony is taking excessive time at an obstacle.
- Maximum time of sixty (60) seconds per obstacle. Refusals do not constitute class disqualification.
- Off course is defined as:
 - 1. Taking an obstacle in the wrong direction.
 - 2. Negotiating an obstacle from the wrong side
 - 3. Skipping an obstacle unless directed by the judge
 - 4. Negotiating obstacles in the wrong sequence
 - 5. Off pattern
- Cause for elimination:
 - 1. Carrying a whip or crop
 - 2. Handler physically moving or coercing the pony by touching the pony (handler must maneuver the pony using the lead, halter or bridle only.)
 - 3. Willful abuse
 - 4. Major disobedience such as rearing.

In-Hand Jumping (46" and under only): This is a class where the handler jogs beside the pony on the left side with the pony jumping the jumps. Pony to be shown in halter with appropriate lead, chain on lead is permitted. Jumps may consist of hay bales, plastic pipe, etc. See rule book for list of acceptable objects.

- Jumpers are to be scored mathematically on accumulated faults incurred and on time to complete the course in case of ties between the start and finish line. Circling once upon entering the ring and once upon leaving the ring is permissible, but not after crossing the start line. There will be one (1) round which will be both scored for faults and timed. Exhibitors will be placed in order of faults, time used to break any ties.
- Cause for elimination:
 - 1. Three (3) total refusals
 - 2. Off course
 - 3. Fall of horse and/or exhibitor
 - 4. Failure to pass through the start/finish line
 - 5. Loss of control, dropping the lead, horse running away or horse exiting on its own.

In Hand Hunter (46" and under only): This class is typically the same as your in-hand jumping except the way that is judged.

- Hunters are to be judged on style, manner and way of going with preference given to those horses who cover the course at an even pace, with free-flowing strides, as in a brisk trot, canter, but must maintain same gait throughout the course. Circling once upon entering is permissible.
- Trot past the judge for soundness check is mandatory (done after all members have jumped and in jump order straight line).
- Cause for elimination:
 - 1. Three (3) total refusals
 - 2. Off course
 - 3. Crossing your own path
 - 4. Fall of horse or exhibitor
 - 5. Jumping of obstacle by exhibitor
 - 6. Carrying a whip
 - 7. An unsound horse
 - 8. Failure to pass through start/finish and/or knocking over cones.

Explanation of Driving Classes

Working pleasure: This class is judge mainly on the horse; this class is to be judged on the performance, manners, suitability quality presence and the apparent ability to give a good pleasure drive.

You should be asked to enter the ring to the right at a working trot. All gaits will be performed in both directions of the ring. In the lineup, horses must stand quietly squared or parked, stay checked at all time and back readily. Attendants are permitted to assist in lining up the horse, wiping the horse, checking the reins and overcheck, and giving assistance to ensure driver safety. The attendants should step back as the judge approaches.

Scorecard for this class: 70% on performance, manners and way of going

20% on condition and fit of harness and vehicle

10% on appointments of horse, driver and attendant (header)

Reinsmanship (Driving Equitation): This class is judge mainly on the driver. The driver should be seated comfortably on the seat so as to be relaxed and effective. The elbows and arms should be close to the body with an allowing, but steady hand enabling a consistent feel with the horse's mouth. An allowing, but steady hand permits the horse to move forward, but maintains steady contact on the horse's mouth to facilitate cuing.

Way of movement will be the same as the working pleasure class.

Scorecard for this class: 75% on driver's performance (handling of reins and whip, control, posture and overall appearance.)

25% appointment of horse, drivers and attendants, condition and fit of harness and vehicle, and neatness of attire.

Drive and Ride: To be shown as a pleasure driving class driving the vehicle, both ways of the arena at a walk, slow trot, working trot and extended trot to stand quietly and rein back.

Under saddle to be shown both ways of the arena at a walk, trot and extended trot, to stand quietly and to rein back.

> Scorecard for this class: 50% on performance, manners way of going and suitability in harness 50% on performance, manners and way of going under saddle.

Drive and Showmanship: To be shown as a pleasure driving class driving the vehicle, both ways of the arena at a walk, slow trot, working trot and extended trot to stand quietly and rein back. Showmanship pattern will be designed by the judge and judged as a showmanship class.

Scorecard for this class: 50% on performance, manner, way of going and suitability in harness 50% on performance, manner and presentation of pattern

Obstacle Driving: This is typically a timed class. This class shown as a cone course, gamblers choice, scurry obstacle, pick your route, or cross-country etc. In this class it can be scored on the following: time, faults and/or points of obstacles. The course and all rules are posted at the beginning of the driving show. These classes are also practiced at workouts.

Driven Dressage: The Dressage test is encouraged to be driven by memory, but may be called at all levels. These tests are available from your driving leaders.

Dressage is scored on each movement and scored from 0-10 with 0 being the lowest of scores. If a competitor makes an error on the course the judge will ring a bell or blow a whistle and stop the competitor, who should then continue the test at the point the error was made, the judge will show the competitor if necessary. Every error will be penalized.

St Joseph County 4-H Horse Council Official Height Measurement of the 4-H Project Horse/Pony/Miniature

Adopted March 2009




Figure 1. Measuring a horse.

- 1 Stand the animal on a smooth, level surface so the front legs are vertical and the back of the hocks are in a vertical line with the point of the hip (see fig 1.)
- 2 Hold the animal's head only low enough to reveal the highest point of the withers and no lower. With the horse in this position, measure the vertical distance from the highest point of the withers to the ground. If the horse is deemed a miniature horse then it will be measured at the base or last hairs of the mane and shall be no taller than 38".
- 3 Place the arm of the measuring standard over the highest point of the withers, or if deemed a miniature horse, at the base of the last hairs of the mane. No measurement taken at any other point than stated above will be accepted.
- 4 The standard shall be a straight, rigid official measuring stick and should be provided with a plumb bob or spirit level to make sure the standard is perpendicular from the withers or base of the last hairs of the mane to the ground and that the crosspiece is parallel to the ground.
- 5 Ponies must measure 56 inches or less at the withers, miniature horses must measure 38 inches or less at the base of the last hairs of the mane.
- 6 Shod ponies or miniature horses will be allowed 1/2 inch for the thickness of the shoes.
